2009 NEA Representative Assembly and Annual Meeting

The 2009 NEA Representative Assembly and Annual Meeting took place from July 1st through July 6th in San Diego, California. 8,860 elected delegates were in attendance including 161 delegates from Nevada.

Highlights of this year's Representative Assembly and Annual Meeting included a Town Hall Conversation with U.S. Secretary of Education Arne Duncan and a tribute to retiring NEA General Counsel Bob Chanin.

Elections included adopting three out of five Bylaw amendments and electing the following NEA officers:

Secretary-Treasurer – Becky Pringle (PA)

Executive Committee – Joyce Powell (NJ)

Executive Committee – Greg Johnson (OK)

Business included Resolutions, Legislative Amendments, and discussing 87 New Business Items including the passing of one presented by Bonnie Peck for the Nevada Delegation concerning the passage of the Employee Free Choice Act.

Here is the adopted text of New Business Item 82:

NEA through its programs, publications and affiliates promote and publicize the importance of the passage of the Employee Free Choice Act.

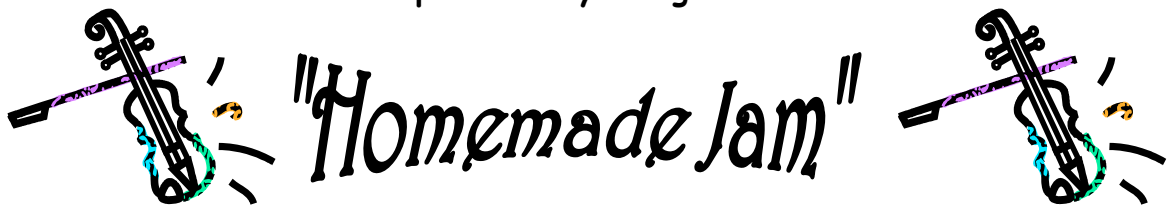
